AN ORDINANCE AMENDING ORDINANCE 1978-3, ORDINANCE 1997-2 AND  
ORDINANCE 2004-1

AN ORDINANCE OF THE BOROUGH OF HALLAM, YORK COUNTY,  
PENNSYLVANIA, GOVERNING THE USE OF THE HALLAM BOROUGH PARK  
KNOWN AS C.E. EMIG COMMUNITY PARK, AND PROVIDING FOR RULES AND  
REGULATIONS FOR THE PROTECTION AND SAFETY OF THE PUBLIC USING  
THE FACILITIES, THE FACILITIES ITSELF AND SURROUNDING NEIGHBORS  
AND NEIGHBORHOOD AND PROVIDING FOR PENALTIES FOR THE VIOLATION  
OF ANY SUCH RULES AND REGULATIONS

WHEREAS, Hallam Borough has heretofore adopted Ordinances governing the use and maintenance of the C.E. Emig Community Park; and

WHEREAS, Ordinances were adopted governing the C.E. Emig Community Park known as Ordinance 1978-3, Ordinance 1997-2 and Ordinance 2004-1; and

WHEREAS, it is the desire of Borough Council to amend and update those Ordinances.

NOW, THEREFORE, BE IT ENACTED AND ORDAINED, AND IT IS HEREBY ENACTED AND ORDAINED AS FOLLOWS:

Section 16-101 of the Codification of Hallam Borough Ordinances, Governs Rules and Regulations applicable in C.E. Emig Community Park.

The use of the C.E. Emig Community Park by the public shall be subject to the following rules and regulations that are adopted for the protection and safety of the public visiting and using those facilities as well as for the protection and safety of the property made available for public use by Hallam Borough:

1. The hours for this park shall be from 8 a.m. to dusk.
2. The pavilion may be reserved by phoning the Hallam Borough Office. There will be a charge for the use of a pavilion, that shall be established, by a resolution of Hallam Borough Council, from time to time.
3. No motorized vehicles (including motorcycles, mini bikes and snowmobiles) shall be allowed anywhere in the park except in the parking lot.
4. Littering is prohibited. All trash shall be placed in trash receptacles.

5. No bicycles shall be allowed in the pavilions.
6. There shall be no hanging from or climbing on pavilion rafters.
7. No open fires shall be allowed, for any reason.
8. No horses shall be allowed in the park.
9. No person shall at any time bring into or upon the property of the C.E. Emig Community Park nor have in their possession nor discharge nor set upon that property a revolver, pistol, shotgun, rifle, air rifle, air gun, paint ball gun or any gun, firearm, bows and arrows or other weapon that discharges projectiles either by air, explosive substance or other force. Provided, however, that this section shall not apply to any law enforcement officers while carrying out the duties of their respective offices.
10. There shall be no trapping, hunting, disturbing or harming in any way the wild life in Emig Park.
11. Tent camping is not allowed, for any reason.
12. No alcoholic beverages or drugs of any nature whatsoever allowed on Emig Park premises.
13. It shall be unlawful to willfully deface or damage any building, seats, benches, equipment, trees, plants, shrubbery, grass, flowers or any other property pertaining to such park area or dig any holes or cut any sod.

14. Skateboarding is not allowed in Emig Park.

Section 16-102 Penalty for violation.

Any person who violates any provision of Section 16-101, after a hearing before a District Magistrate, shall be subject to a fine of not less than \$50 or more than \$1,000 for each offense.
